## Redeploy Illinois

**Redeploy** is a state funded program which provides services to youth who are at very high-risk of incarceration in the State of Illinois prison system. LaSalle County was awarded the grant in 2012, becoming only the 9th funded site in the state. The grant was expanded in November, 2013, to include the entire 13th Judicial Circuit, that being Bureau, Grundy and LaSalle Counties. The Court Services of that Circuit contracted with Youth Service Bureau of Illinois Valley (YSBIV) to provide the following services:

- Clinical treatment
- Case management
- Transportation
- Advocacy
- Linkage to other services

**Youth are referred to the program by the 13th Circuit Court Juvenile Probation Officers and the State's Attorney's from the respective counties, working in conjunction with the Juvenile Judges and the Public Defender.**

## Individualized Services:

Each youth begins the program with a Youth Assessment and Screening Instrument (YASI) assessment. If substance abuse concerns are identified, the youth is referred to the local county mental health agency or an in-patient treatment facility to address these needs. All other issues such as mental health, trauma, behavioral and familial conflict, are addressed by the treatment team at YSBIV. The treatment team is comprised of Master's level therapists, Bachelor's level case managers and transporters.



## Family Services:

Services are provided to the entire family as well as the identified youth. An evidence-based treatment model, "Parenting with Love and Limits" (PLL), is utilized to work with the clients. PLL guides the family to identify the youth and family needs and goals. The therapists and caseworkers use the PLL model to assist the family in developing individualized methods to address the identified needs and goals. All treatment is addressed from a strengths perspective and the belief that the family knows best what is needed to achieve the goals they have for their lives.

## Overview:



**Redeploy Illinois** was created in 2004 by the General Assembly to provide services to youth at risk of commitment to the Illinois Department of Corrections. The program is funded by the Illinois Department of Human Services. The 13th Judicial Circuit is one of 11 Redeploy sites in the state. Youth Service Bureau provides intensive service to these youth and their families, thus reducing the incidence of criminal recidivism in the community and incarceration of adolescents in the Illinois prison system.
