# Do What You Actually Can.



Whenever I hear anyone mutter, "Let's do it for the children, or this needs to occur because "It's in the best interest of children", I hesitate and usually realize that those are empty words meant for the moment, or the sound effect to refute any contrary opinion. How else could we be in the state of a mess that calls itself *Child Welfare in Illinois*. How could teachers go on strike when students can't meet minimum standards? How could nurses go on strike when a patient has a pro-

cedure scheduled the next day? How could politicians legalize marijuana when studies show the negative consequences that result? How could a casino in Chicago be passed and it is taxed so heavily that no one will build it? The answers are usually connected to money, the feeble rationale that money will make things better. Maybe sometimes it can help, but seldom does it cure the ill.

This sad state of affairs has resulted from us who keep electing these incompetent officials in both parties who don't have a creative idea or who couldn't recognize one if it hit them square on the nose. **Child Welfare for children is in total chaos**, and the state agency responsible is sinking further away from handling their legal duties. Advocacy groups have not fared better. They seem to take a cozy chair alongside these failing institutions instead of challenging their foundations. Most of the experienced state child welfare workers have retired or have circled their date on the calendar to get out. They have been replaced by the level under them who lack experience or proper training. The second level is being replaced by new inexperienced personnel or any functioning body off the street that the state can muster.

I recently had to send workers to a mandatory 2-day training put on by the state. They reported back it was a total waste of time. We informed the state officials of this, that outdated forms were being used in the training and that training on procedures that staff could no longer complete were being utilized. We never really got a response back. One month later we had to send other staff to this training. It was reported nothing had really changed. The official announcement of this training looks good, sounds good, but has no substance.

So, where does all this leave Youth Service Bureau in this uncertain scenery of chaos all around us? Our agency, Youth Service Bureau needs to continue to focus on what we do. We serve children and families in our programs, and we need to always be mindful that we ensure, we practice, we meet, and we go beyond our own standards. We can't rely on others, such as state officials, state departments, or advocacy's groups to show us or anyone the way. Youth Service Bureau needs to demonstrate our commitment to providing our services and always make the case to our friends, donors, and supporters that we do what we say.

Our commitment is to the children we see and serve each day - children who have suffered some type of trauma that they will carry the rest of their lives. Youth Service Bureau needs to always hold onto this unwavering support to these children and to our friends and donors that we will always do our best given the circum-

stance that surround us. Youth Service Bureau can always be counted on! I think it is good for Youth Service Bureau and its staff to always be mindful of the words that a 10 year old foster child in our program who wrote a poem: "The Pain You Put Me Through"

Do you know the pain you put me through?
The horrible pain of wondering
Wondering if I am staying at this house
Or at that house

The horrible pain of not knowing
Not knowing if I will have food
Food for the rest of the week
And what about my brother

The horrible pain of being a parent
Only when I am 10 years old
10 years old and taking care of a child
And the child isn't mine

The horrible pain of the cops
The cops coming in the door
And pinning him down
And waving good bye not knowing if I will see him again

Wondering
Will I ever have a normal life

And Youth Service Bureau always needs to remember our real responsibility is to these children and families, and to always <u>"Do What You Actually Can!"</u> to the best of our abilities! Thank you for your continued support.

# The Programs That We Offer

#### **Foster Care**

A program for children in state custody who are unable to remain safely in their home. Children in foster care stay with a family who provides safety, nurturing support and role models for change. Foster care is meant to be a temporary, short term solution to an emergency situation. Foster placement may be for a single day or several weeks and some continue for years. (Available in 20 counties.)

#### **Children First**

For divorcing parents who have been mandated by a Family Court Judge in the 13th Judicial Circuit of Illinois to participate in an educational program regarding problems and issues of divorce when children are involved. (Available at YSB offices in Ottawa, LaSalle and Princeton.)

#### Runaway and Homeless Youth Counseling Program

Serves youth 11-17 providing crisis intervention, short term counseling and linkage to appropriate services for runaway and homeless youth that are at risk of running away or becoming homeless. (Available in LaSalle, Putnam, Bureau, Stark and Marshall counties.)

#### Intensive Placement Stabilization

Provides various services to assist in stabilizing a child in foster care placement. (Available in LaSalle, Bureau, Marshall, Putnam and Stark counties.)

#### **Intact Family Services**

A program established by the **Department of Children and Family Services (DCFS)** meant to provide reasonable efforts to preserve families to enable children to remain safely at home and avoid separation and/or placement of the children. (*Referrals by DCFS only in Bureau, Du Page, LaSalle, Marshall, Putnam, Stark, McHenry and Winnebago counties.*)

#### **Street Outreach**

For young adults ages 16-24 years of age who are living in unstable and non-traditional living arrangements. Youth are linked to area services, taught independent living skills, and aided in finding jobs. It is the goal of YSB to keep youth off the streets and safe. (Available in LaSalle, Putnam, Bureau, Stark and Marshall counties.)

#### **Transitional Living Program**

Homeless youth (ages 16-24) are helped in finding safe and stable living accommodations and services that provide basic life skills, job searching, mental health services and educational opportunities to make a successful transition to self-sufficient living. (Available in LaSalle, Putnam, Bureau, Stark and Marshall counties.)

#### Redeploy Illinois

Redeploy Illinois was created in 2004 by the General Assembly to provide services to youth at risk of commitment to the Illinois Department of Corrections. The program is funded by the Illinois Department of Human Services. The 13th Judicial Circuit is one of many Redeploy sites in the state. Youth Service Bureau provides intensive service to these youth and their families, thus reducing the incidence of criminal recidivism in the community and incarceration of adolescents in the Illinois prison system. Referrals are made by the 13th Circuit Court Juvenile Probation Officers and the State's Attorney's from Bureau, Grundy and LaSalle Counties, working in conjunction with the Juvenile Judges and the Public Defender.

#### 2nd Chance

Second Chance provides services to youth who would otherwise be removed from their homes and communities due to high-risk, unmanageable behavior. These adolescents have demonstrated significant emotional concerns which may include mental health and trauma issues. Intensive services are provided to the youth and their families through Youth Service Bureau. The program is funded through the LaSalle County 708 Board. Referrals are made by the LaSalle County Juvenile State's Attorney's office and the LaSalle County Juvenile Probation Department.

#### **Solutions Counseling**

Offers intensive out-patient and mental health therapy treatment by Master degreed and licensed therapists trained in child and family centered intervention; Includes individual, marital and family counseling. Counseling is available for Children and Adults and most insurance companies are accepted. (Available in the following offices: Ottawa, LaSalle, Princeton and Streator.)

#### **Youth Giving Back**

Community Services/Restitution works closely with local courts, Peer Courts, Police Departments and Juvenile Probation to involve young people in meaningful work projects to "pay back" their community for petty delinquent offenses. (Available in LaSalle County.)

#### **Hispanic Services**

Provides families with information in Spanish and links them to services in Spanish. Includes collaboration with Illinois Valley Community College literacy programs. (Available in Bureau, DeKalb, Grundy, LaSalle, Lee and Putnam counties.)

#### **Hope House**

Provides supervised visitation and exchange for children in homes with a history of domestic violence, sexual abuse, stalking or child abuse. The focus is to keep all parties safe. (Available in LaSalle county.)

#### **Traditional Parenting Program**

Provides parents the opportunity to enhance their parenting skills, set appropriate expectations and limits. Clients must be 18 years of age or older. Referrals are made by the following: DCFS, Probation, self, Churches and Community. (Available in Rockford, Freeport and Belvidere.)

# **YSB Training Spotlight**

#### **Trauma Informed Care and LGBTQ+ Awareness Training**

Youth Service Bureau of Illinois Valley held an all-staff training on "Trauma Informed Care" and "LGBTQ+ Awareness". The full day event was held at Grand Bear Lodge in Utica, IL on November 16, 2018.



The training included information on the causes and effects of sustained trauma in youth who come into our care, as well as how to help these clients in a way that doesn't place additional trauma on them.

Additionally, staff were educated on the meaning of each letter in the LGBTQI+ (LGBTTQQIAAP: lesbian, gay, bisexual, transgender, transsexual, queer, questioning, intersex, asexual, ally, pansexual) acronym and how to approach and

respect each individual's identity.

The training was presented by Dr. Caryn Andrews, who has over 16 years of experience in the fields of Law Enforcement and Court Services. As a sworn law enforcement officer for over 13 years, she became passionate about educating first responders on mental health related issues, and responding to calls involving people with mental illness. She was the first police officer at her department to become a certified Crisis Intervention Team member in Kane County in 2010.

Dr. Andrews holds a Doctorate in Clinical Psychology from the Illinois School of Professional Psychology. She is currently the psychologist for the Kane County Juvenile Justice Center, where she is responsible for delivering psychological services to juveniles in the criminal justice system, as well as being responsible for the psychological safety of juveniles during their detention.

Staff at YSB are required to receive training throughout the year, credits varying between programs, to further their understanding of child welfare, mental health issues, and modern updates to treatment. Training keeps each staff member at the forefront of their profession, and is highly beneficial to those in the community who need special treatment and care.

Lam Le came to YSB to become a foster parent through recommendations from other professionals in the field. She has wanted to care for her own children and others' children ever since she was a child. She wants other children to know what it is like to have the love and security from safe, trustworthy adults.

Lam always supports the return of foster children to their biological mother. One biological mother was so

grateful for Lam's open communication and support of her effort to have her children back that she informed the courts about her feelings.

Julia and Nick began their foster care journey by going on mission trips to Togo and Haiti. They could not help but be impacted by the suffering and general lack of care the orphans were facing. They considered adopting internationally but as they considered further how they could help, they came to the realization that for whatever reason, God placed them in America. After Julia's mother passed away she realized what it

was like to not have a mother and didn't want that for anyone.

Nick and Julia have written about their journey as foster parents:

"Being a foster parent is challenging on several levels. Outside forces that are beyond our control play a large role in the life of a foster parent. We find the best way to handle these challenges come by focusing on what our role is. We are responsible to provide love through guidance, daily care, and education. It's not our role to know the future or even try to figure that out."

#### Thomas "TJ" and Trinity Heck 3rd Quarter FY19 (April 2019)

Thomas "TJ" and Trinity Heck originally began their foster care journey by helping out a family member whose child was born with substance exposure. They were willing to do whatever was necessary to help. Additionally, they recently took on another substance exposed infant and have been caring for him since his release from the hospital. When the foster babies are sick in the hospital, both parents take turns to be there around the clock.

In addition to their foster family, they have three children of their own...two of which came through private adoptions. On top of raising 5 children from the ages of 3 months to 18 years, they also run an in-home daycare together, which has been going strong for over 8 years.

TJ and Trinity are not only amazing foster parents, but they are also genuinely great people with huge hearts. YSB is lucky to have such dedicated people on our team who believe so strongly in our mission.



#### **Stephannie and Jacob Neumann** 4th Quarter FY19 (July 2019)

Stephannie and Jacob Neumann have been foster parents since February of 2013. Throughout their journey, they have provided care and permanency for three children. They have always gone above and beyond with the children in their care, whether it was driving them to visit family, to counseling, or to any other service necessary for them to flourish and grow.

Each year, the Neumann's have sponsored other chil-

dren to receive Christmas gifts in YSB's Star Tree program. They have fulfilled their calling to be foster and now adoptive parents.


